Appendix A. IKOKC Consent Form and Authorization for Release – Members who are Dojo Operators and unpaid Instructors - who are supervising, instructing, teaching, training, directing, interacting, working with Vulnerable Persons (children and adults).

IKOKC hereby informs you that it requires certain Members as defined under the Scope of this Policy to apply for and complete a CRC/VSC with the assistance of local Police Services/Forces or RCMP Detachments. The CRC/VSC covers relevant and specified Offences (as attached in Appendix B and which forms part of this Consent application) for review. As part of the CRC/VSC process the Applicant may be required to have his/her fingerprints taken to assist in verifying Individual identification and personal information.

Within 10 business days Applicant will apply in person, complete and sign a Police Consent to a CRC/VSC form, attach IKOKC Appendix A and B documents, provide identification and proof of residency, and pay any required fees. Certain police jurisdictions may grant fee exemptions, as IKOKC is incorporated federally as a non profit Sports Corporation.
